- M2.2. The logo of the club shown is only temporary, members are welcome to suggest their own designs.

- M2.3. On Item 3(d) of the Constitution about the goals of the club, the word "sole" is dropped.

- M2.4. On Item 13 of the Constitution, the maximum number of members allowed to attend the committee meeting was discussed, however, there was no consent on this issue, it was noted that only the committee members have the right to vote in the committee meeting.

- M2.5. On Item 16 of the Constitution, the word "Secretary" should be replaced as "Committee".

- M2.6. On Item 17 of the Constitution, "two-thirds of the voting members" "should be replaced with "two-thirds of the voting members present in the meeting". Actually the English version is correct, only the Chinese version needs revision.
在協會會章第17節, 把句子「本會三份二的有投票權的會員」改成「出席大會三份二有投票權的會員」
