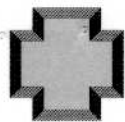

## PUBLIC LIABILITY POLICY

---

Whereas the insured carrying on the Business described in the Schedule and no other for the purposes of this insurance by a proposal and declaration which shall be the basis of this contract and is deemed to be incorporated herein has applied to BLUE CROSS (ASIA-PACIFIC) INSURANCE LTD. (hereinafter called the Company) for the insurance hereinafter contained and has paid or agreed to pay the Premium as consideration for such insurance.

Now this Policy Witnesseth that subject to the terms exceptions and conditions contained herein or endorsed hereon the Company will indemnify the Insured against all sums which the Insured shall become legally liable to pay as compensation in respect of

- (a) accidental bodily injury or illness to third parties
- (b) accidental loss or damage to property belonging to third parties

caused on or about any of the places specified in the schedule through the fault or negligence of the Insured or his employees whilst engaged in the course of the operations described in the schedule hereto or by any defect in the ways works machinery or plant of the Insured connected with or used in the operations specified in the schedule.

The liability of the Company for all compensation payable in respect of or arising out of one occurrence or in respect of or arising out of all occurrences of a series consequent on or attributable to one source or original cause shall not exceed the amount specified in the schedule as the Limit of Liability for any one accident and the liability of the Company in any period of insurance shall not exceed the amount specified in the schedule as the Limit of Liability in any period of insurance.

In respect of a claim for compensation to which the indemnity expressed in this policy applies the Company will also indemnify the Insured against

- (a) all costs and expenses of litigation recovered by any claimant from the Insured and
- (b) all costs and expenses of litigation incurred with the written consent of the Company in resisting any claim. In the event of the death of the Insured the Company will in respect of the liability incurred by the Insured indemnify the Insured's personal representatives in the terms of and subject to the limitations of this policy provided that such personal representatives shall as though they were the Insured observe fulfil and be subject to the terms exceptions and conditions of this policy so far as they can apply.

### JURISDICTION CLAUSE

The indemnity shall not apply in respect of judgements which are not in the first instance delivered by or obtained from a Court competent jurisdiction within Hong Kong.
